

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://indianafilter.com/> and Indiana Filter Supply and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Indiana Filter Supply include <https://indianafilter.com/> and IFS. The IFS website is a ecommerce site. By using the IFS website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered on our Site, IFS may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase IFS's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

IFS may also collect anonymous demographic information, which is not unique to you, such as your:

- Age

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through IFS's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. ## Use of your Personal Information

### **Sharing Information with Third Parties**

IFS does not sell, rent or lease its customer lists to third parties.

IFS may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to IFS, and they are required to maintain the confidentiality of your information.

IFS may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on IFS or the site; (b) protect and defend the rights or property of IFS; and/or (c) act under exigent circumstances to protect the personal safety of users of IFS, or the public.

### **Tracking User Behavior**

- context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
  - Debug to identify and repair errors that impair existing intended functionality;
  - Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
  - Comply with the California Electronic Communications Privacy Act;
  - Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
  - Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
  - Comply with an existing legal obligation; or
  - Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
